OFFICIAL RULES

<u>Rule 1</u>: The Youth City Tournament will be open to all members of the Greater New Orleans USBC (Youth) Association and will be conducted under the regulations of the United States Bowling Congress (USBC). All members are required to have their membership cards. Every youth bowler's \$25.00 entry fee will be returned to them 100% by crediting it into their Smart Fund scholarship account.

Rule 2: The Youth City Tournament format will be a handicapped tournament competed with three (3) person teams, bowling three (3) games each.

Rule 3: A handicap based on 90% of the difference between the team's total average and the tournament scratch basis score of 675 pins per game.

Rule 4: Average: Bowlers' averages will be determined using the following priority:

- A Bowler will use his/her highest 2023-2024 book average of 12 or more games.
- B If none, bowler will use his/her highest current Fall 2024 or Spring 2025 sanctioned league average (January 2025 league start up) of 12 or more games as of April 26, 2025.
- C If none, bowler will use a verifiable 2024 Summer League average based on 12 games or more.
- D If none of the above, bowler must use an average of 225. The committee reserves the right under USBC rule to adjust any questionable average to the satisfaction of the entrant or entrants or return the entry and fee.
- E. The USBC 10-pin average Rule 319a-2 will apply to all entrants.

<u>Rule 5:</u> Multiple participation in 3-person team event is allowed. Bowlers are permitted to bowl in the team event as often as they desire provided that at least one (1) player in the lineup is different.

- Rule 6: One Hundred percent (100%) of prize fee will be returned in USBC Smart Fund Program. Prize ratio will be paid on 1 in 4 for this event.
- Rule 7: Entries will be accepted up to forty-five (45) minutes prior to each squad provided there are lanes available.
- Rule 8: Bowlers must check in at the tournament office at least thirty (30) minutes prior to the start of their squad.
- Rule 9: Bowlers arriving late will not be allowed to catch up and will receive zero pins for each frame missed.
- Rule 10: PROTESTS and APPEALS: Any protest affecting eligibility or general playing rules must be confirmed in writing and filed with the tournament manager within seventy-two (72) hours of the infraction, For additional information and requirements, see USBC Rule 329.
